~~AUTHORIZING THE MAYOR OF THE CITY OF HUBBARD TO ENTER INTO THE PY 2024 CHIP PARTNERSHIP WITH THE CITIES OF NILES, GIRARD AND CORTLAND FOR THE PY 2024 COMMUNITY HOUSING IMPACT AND PRESERVATION PROGRAM FUNDS (CHIP) WITH THE OHIO DEVELOPMENT SERVICES AGENCY, OFFICE OF COMMUNITY DEVELOPMENT, AND DECLARING AN EMERGENCY.~~

~~WHEREAS, the State of Ohio, Development Services Agency, provides financial assistance to local governments, participating in a partnership, for the purpose of addressing local need; and,~~

~~WHEREAS, the City of Hubbard desires to participate in the PY 2024 CHIP Partnership to receive financial assistance for community housing improvements; and,~~

~~WHEREAS, the City of Hubbard has the authority to enter a PY 2024 CHIP Partnership with the Cities of Niles, Girard and Cortland to apply for financial assistance from the State of Ohio, Development Services Agency, through its Community Housing Impact and Preservation Program; and,~~

~~WHEREAS, the Council of the City of Hubbard must direct and authorize the Mayor to act in connection with the PY 2024 CHIP Partnership Agreement and to provide such additional information as may be required.~~

~~NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Trumbull County, Ohio:~~

~~SECTION 1: That the Hubbard City Council authorizes the Mayor as the official representative of the City of Hubbard to participate in the PY 2024 CHIP Partnership for the State of Ohio, Development Services Agency's PY 2024 Community Housing Impact and Preservation Program, and provide all information and documentation required in said partnership agreement for application for submission.~~

~~SECTION 2: All prior Ordinances and Resolutions or parts thereof in conflict with this Resolution are hereby repealed.~~

~~SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public in compliance with Section 121.22 of the Ohio Revised Code.~~

~~SECTION 4: That this Ordinance is hereby declared to be an emergency measure and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard Ohio and for the additional reason that the grant application must be submitted in a timely manner.~~
