AN ORDINANCE
CITY OF HUBBARD, OHIO

AMENDING AND SUPPLEMENTING HUBBARD CITY CODED ORDINANCE 615.15 PROHIBITING MEDICAL MARIJUANA CULTIVATOR AND PROCESSOR ESTABLISHMENTS, LIMITING THE NUMBER OF MEDICAL MARIJUANA DISPENSARIES TO ONE WITHIN THE CITY LIMITS, AND PROHIBITING THE SALE OF RECREATIONAL MARIJUANA, AND DECLARING AN EMERGENCY.

RESOLVING WHEREAS the City of Hubbard, Ohio deems it necessary to amend certain ordinances from time to time as state law changes; and

ORDINANCE NO. PASSED 20

WHEREAS, state law has permitted municipalities to regulate establishments engaging in the cultivating, processing and dispensing of medical marijuana;

CITY OF HUBBARD, OHIO

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Trumbull County, State of Ohio:

SECTION 1: The cultivation or processing of medical marijuana, even under a license issued under Chapter 3796 of the Ohio Revised Code, is prohibited within the City of Hubbard. The number of medical marijuana dispensaries shall be limited to (1) one within the Hubbard City limits. The sale or dispensing of recreational marijuana shall be prohibited within the City of Hubbard. Violation of this Ordinance is a misdemeanor of the fourth degree.

SECTION 2: This Ordinance is hereby declared to be an emergency Ordinance and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard, Ohio.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
