AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH RICHARDSON TREE AND LANDSCAPE COMPANY FOR 2024, 2025, AND 2026, NOT TO EXCEED \$60,000.00 PER CALENDAR YEAR, AND DECLARING AN EMERGENCY AND RESOLUTIONS

~~WHEREAS, the City of Hubbard, Ohio wishes to limit the potential electrical system damage due to trees, limbs and high winds/storms; and~~

RESOLVING (WHEREAS) the City of Hubbard, Ohio needs tree trimming services pursuant to Ohio law; and

~~WHEREAS, the City of Hubbard, Ohio needs tree trimming services to prevent interruption of electrical service to consumers;~~

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control of the City of Hubbard, Ohio, is hereby authorized and directed to enter into a contract with Richardson Tree and Landscape Company in an amount not to exceed sixty thousand dollars (\$60,000) per calendar year for the years 2024, 2025, and 2026.

SECTION 2: That all fiscal officers are hereby authorized and directed to immediately encumber funds in the amount of \$60,000, per calendar year, as and for consideration in the light of Fund #705, *Tree Trimming* line item 705-5010-5-2345, for the purpose of satisfying the Richardson Tree and Landscape Company service contract.

SECTION 3: This Ordinance is hereby declared to be an emergency Ordinance necessary for the health, safety, and welfare of the City of Hubbard, Ohio by virtue of the facts mentioned in the preamble hereto, which is made part hereof, as that tree trimming services are necessary and required to prevent electrical outages as routine maintenance and cleanup of fallen trees and branches during periods of inclement weather, and as such, this Ordinance shall take effect immediately upon passage and approval by the Mayor, or in the alternative, from the earliest time permitted by law.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law
